# Accountability - new, statutory obligations regarding documentation

The General Data Protection Regulation (GDPR) will apply as of May 2018. It envisages that corporate entities are accountable for ensuring compliance with data protection law. Companies must be able to provide proof that they established processes to implement data protection law, that they regularly monitor and document results. This compliance requirement can only be met efficiently by the use of software which assists in this respect.
