# What does SaaS mean?

It means that the software and the IT infrastructure are operated by an external IT service provider and used by the customer as a service. SAP calls this model Partner Managed Cloud (PMC). Here we are the partner who not only provides you the license rights, but also all services for the operation and implementation of the solution during the contract period.

### Which services are included in the SaaS lodel:

- Operation of hardware and SAP applications including release changes
- Delivery and regular import of data content (e.g. sanction party lists, commodity codes, preference rules/agreements, TARIC etc.)
- Connection to the customs authorities for the exchange of electronic customs declarations
- Monitoring of all SaaS components (SAP GTS, Seeburger, mail server, PDF server, etc.)
- All licenses required for the service (SAP GTS, database, operating systems, etc.)
- Development of special processes e.g.: worst case price, automated LLE/KLE creation within a company (intercompany process) etc. (processes that are not available in the SAP standard)
- Access to the SAP GTS ticket system with predefined service levels

This means that you need only one contract with us and we provide you with all required services for the operation of the SAP GTS solution.


