

The “Pathways to Paris” transformation tool assists you in detailing your company’s path towards climate neutrality and in implementing the associated measures in a cost-efficient manner.




What makes the transformation tool stand out?

- Climate and industry experts from PwC Germany and WWF Germany developed the tool as part of the “Pathways to Paris” project.
- The tool is based on the scenario “Towards a Climate-Neutral Germany by 2045”, which was published by leading research institutions in Germany in 2021 as a reference for sector-specific transformation pathways that align with the targets of the Paris Climate Agreement.
- The requirements and assumptions were validated in a series of 30 workshops with over 80 actors from the real economy, the financial sector and academia.
- It is available as a free-of-charge web-application without any data being stored.



How does the tool benefit the transformation of your company?

Three steps are needed to arrive at your customized transformation pathway:

Thanks to sector-specific transition pathways, you will be better able to understand the minimum requirements for reducing emissions in accordance with the Paris Climate Agreement.

The tool allows you to test the effects and costs of various reduction measures and provides you with an overview of the outcomes in graphic form.

You can plan the implementation of the selected measures (roadmap) and assess the cost implications of the transformation plan over time.
